### **TOP 100 COMPANIES**

iming to strengthen bonds within the Wakefield District business community, the Wakefield Top 100 Companies is a joint venture between Wakefield First as part of Wakefield Council, the University of Huddersfield and the 3M Buckley Innovation Centre (3M BIC).

It will help to raise the profile of businesses within the Wakefield District and promote the district as an attractive destination for inward investment, business start-up, development and growth.

Inspired by previous Top 100 models, the Wakefield Top 100 has launched for the first time this year. The list has been determined by a set of consistent metrics, using a combination of turnover, profit, employee numbers and growth, all derived from published information in company accounts.

The Wakefield Top 100 businesses for 2024/25 were unveiled at the official launch event in May 2024, held at Tileyard North, Wakefield. Hosted by the three partner organisations, the top 100 businesses were invited to celebrate the success of businesses across the Wakefield District.

Councillor Denise Jeffery, Leader of Wakefield Council, said: "The Wakefield Top 100 Companies celebrates the success of Wakefield businesses and is a great way to highlight and recognise those who are leading the way.

# HOW THE LIST WAS COMPILED

# Background

The Wakefield Top 100 was compiled using as its source the FAME BVD database that contains a variety of information on more than 11 million companies in the UK and Ireland. The information in the database includes financial data, information on directors, and company structure including shareholders, subsidiaries and branches, and industry descriptions and SIC codes; much of the information derives from accounts and documents filed at Companies House (in the UK). The FAME BVD database is the only source used for the listing.

Strict parameters were used to derive the set of companies from which the Top 100

were ultimately drawn. The first parameter concerned the geographical location of companies in the Wakefield Top 100. Thus, we selected from the FAME BVD database all active companies with a registered office address within the Wakefield District defined as having a postcode in Wakefield (as per the NUTS 3 level region definition). Huddersfield Business School researchers downloaded the relevant data on 1 January 2024, and any data available in the FAME BVD database after this date was not included in this particular edition of the Top 100 list. In order to ensure a Wakefield focus, we added a further check: any company whose website presents as its only contact an address outside of Wakefield was removed even though their registered office was recorded in FAME as in Wakefield. This affected only a very small number of companies.

### ECONOMIC CONTEXT

ompanies continue to face external challenges. While the restrictions of the Covid-19 pandemic are a thing of the past, the lingering impact of the pandemic, as well as Brexit, continue to challenge businesses.

More recently there are new challenges to add to the old ones: the wars in Ukraine and Middle East, the ongoing impacts on supply chains as well as on supply of energy and grain in particular, and the consequent inflationary pressures which have led to interest rates at a 15-year high. In terms of this list, it should be remembered that each company's data is a specific snapshot (indicated by the date in the "Latest Account Date" column) and so the extent of the impact of precise external factors on businesses in this list will vary by company.

### LIMITATIONS

his list does not claim to indicate each business's economic importance to the Wakefield geographical area.

It is based on five specific metrics which are deemed to be indicators of success. All metrics contribute equally to the final ranking. The list can therefore be seen as a means of showcasing and celebrating business activity in the Wakefield District. Unfortunately, not all companies' complete set of data are included in FAME BVD, and some (significant) businesses located in Wakefield do not have a registered primary office in the district. Such businesses which therefore might expect to be in the list do not appear for that reason, yet their contributions to Wakefield may well also be substantial.

# Methodology

his is the first compilation of the Wakefield Top 100 Companies Listing and it is based on the methodological approach of the Kirklees Top 100 for which there have now been 4 annual publications.

Specifically, the ranking is derived from the following indicators: staff head count (i.e. number of employees); turnover; growth in turnover between the latest and previous years; profit before tax; and shareholders' funds. Each of these indicators is ranked (best to lowest performing), and then these rankings are summed. The final position is determined by ranking the sum of ranks. In effect, each of the five metrics carries equal weight in determining the final ranking.

The period over which the ranking applies is determined by the latest information held in FAME BVD and filed by each company in the Wakefield list. Where we identify subsidiaries and sister companies we applied a consistent approach to ensure that the highest or largest company (in terms of revenue) in the hierarchy was retained, so long (of course) as the registered office was in the defined Wakefield area. Companies deemed to be charities or in the education sector, or with turnover less than £1000 or with nonnumeric data were removed from the data set. No businesses were offered the option of being included (or not).




### THE WAKEFIELD CONTEXT

ince this is the first publication of the Wakefield Top 100, we have plotted the 100 companies (see map below). The Wakefield District is outlined in dark blue and shaded in light blue. What is clear is that a substantial portion of companies are located in and around Wakefield itself and close to the Leeds side of the district. The remaining portion of companies are located close

to key road arteries such as the M62. Very few are in the South and East of the District.

Wakefield companies span a diverse range of sectors as is shown in the figure below. While manufacturing - particularly of metal, machinery, electricals, food, textiles and furniture - is the sector comprising the highest number of Wakefield Top 100 companies, financial and insurance activities are also well represented. Indeed, when support services more generally (financial plus administrative and other support services) are considered, they actually exceed the number of manufacturing companies. The diversity seen across all 100 companies is replicated in the top 10 with no single sector particularly dominating.





# 1. CARD FACTORY PLC



# 3. DUNHILLS (PONTEFRACT) PLC



he company's roots trace back to Pontefract, where the Dunhill family rented land in Pontefract Castle for growing liguorice. By the 1760s George Dunhill, who became a chemist, is reputed to have added sugar to medicinal recipes to make the first liguorice sweet or 'Pontefract Cake'.

These distinctive treats, made from a blend of liquorice extract and sugar, have become a beloved symbol of Yorkshire's culinary heritage and have captured the hearts of confectionery enthusiasts both locally and abroad.

As the demand for Dunhill's confections grew, the company expanded its product range, introducing a diverse array of sweets to cater to evolving consumer tastes. From fruit pastilles to toffees and beyond, Dunhill's commitment to using only the finest ingredients and time-honoured recipes set it apart from its competitors.

In 1972, the German company HARIBO acquired a major stake in Dunhills and in 1994, HARIBO took the final step to fully acquire Dunhills, which became HARIBO UK.

The company set about revolutionising the UK's sweets market and went on to create new, unique mixes, bringing family favourites together in one bag to create what have become the UK's most popular sweets. Starmix was launched in 1995, followed in 1996 by Supermix, a combination of squishy and soft textures, and in 1997 the HARIBO 'tang' was introduced with Tangfastics.

HARIBO opened a brand-new manufacturing site in Castleford in 2015,

in addition to its world-famous Pontefract site. Around 80% of HARIBO sweets bought in the UK are produced at factories in Castleford and Pontefract. It is estimated the Castleford factory alone has the capacity to produce 48,000 tonnes of sweets every year. HARIBO recently announced plans for a new purpose-built warehouse at its Castleford site.

HARIBO continues to innovate and adapt to changing market dynamics. Recognising the growing demand for healthier alternatives, it expanded its product range to include sugar-free and low-calorie options, ensuring that its confections remain accessible to a diverse range of consumers.



Those chosen include Group Rhodes, Parkside Flexibles, Assyst Bulmer, Rotajet Systems, OE Electrics and Sewtec Automation. All are disruptive leaders in their own markets and helping to fly the flag for innovation across Wakefield.

Having businesses of this calibre on our doorstep is remarkable and there are countless more across the district that didn't make it to the shortlist, that are revolutionising their industries, many of which operate on a global scale.

As a community, we want to celebrate the achievements of these businesses, as well as encourage and support others to embrace innovation to drive forward change across the region.

## COLLABORATION IN WAKEFIELD

Here's how organisations in Wakefield have been working with the 3M BIC to innovate.

### THE POURED PROJECT

The Poured Project is a bespoke concrete goods design company, based in Knottingley, that creates handcrafted basins and baths, combining industrial raw materials with traditional manufacturing techniques to create a unique look for bathrooms.



The 3M BIC's design team worked with the company to generate CAD models, 3D models and technical drawings of a bespoke bath concept using scanning technology. The process captured overall dimensions for fitting purposes and the texture and geometry of the bath that would be demonstrated on product specification sheets and on architectural models.

### CONNECT VM

Connect VM, based in Wakefield, approached the 3M BIC's technology team to support the concept development of a ceiling rose adaptor. A 3D rendered design and 3D printed prototype were created that offered both a practical and cost-effective way of obtaining a simulated product.

After determining that a plastic version of the product wasn't commercially viable, the 3M BIC team 3D printed a metal version, alongside CAD drawing, that were used for further testing.



The final product, The O-Kit, enables easy and secure fitting of a new pendant light to a ceiling without complicated wiring – making it quick for electricians and easy for DIY enthusiasts.


